#### Raffle Rules

Ashtabula County Education Foundation dba Ashtabula County 4-H Foundation 2022 Official Raffle Rules  
The Ashtabula County Education Foundation (“The Foundation”), recognized by the IRS as a tax-exempt 501(c)(3) organization, is sponsoring a fundraising raffle in accordance with the laws of the State of Ohio and shall be known as The Foundation Raffle (“the Raffle”). All proceeds of the Raffle will go to The Foundation and will be used in furtherance of charitable purposes in accordance to the Articles of Incorporation. Rules and regulations of the Raffle are set forth below. By purchasing a raffle ticket (“Ticket”), all ticket purchasers agree to be bound by all rules, limitations and restrictions set forth herein. The interpretation and application of all Raffle rules by The Foundation and its legal counsel shall be final.

**Eligibility:** The Raffle is open to all legal residents of the United States, who are 18 years of age or older as of the date of the drawing, September 17, 2022. All federal, state and local laws and regulations apply. Void where prohibited by law.

**To Enter:** The Foundation and various local community organizations will sell Tickets at a cost of ten dollars (\$10.00) per Ticket or 3 tickets for twenty five (\$25.00). The odds of winning the Prize, as hereinafter defined, will depend on the final number of Tickets sold. Tickets will be sold until the Annual Pig Roast and Auction on September 15, 2018. It is not necessary for the winner to be present to win. The Prize will be on display at various locations. Participants must follow all instructions and submit a complete ticket entry form to be qualified to win the Raffle. Per IRS rules, amounts paid for Raffle Tickets are not gifts to the charitable organization and do not qualify as deductible charitable contributions.

**Online Sales:** Each valid Ticket purchase made online via the Foundation’s website ([www.av4hf.com](http://www.av4hf.com)) will be assigned a unique ticket number (and the information transferred to an entry form) and may not be given away or otherwise transferred. Only the purchaser of the online Raffle Ticket, as determined by credit card purchase records, will be considered the lawful owner of the online Raffle Ticket. Online Ticket sales will end at 12:01 am EST on September 13<sup>th</sup> 2022.

**Prize:** The “Prize” is a new Bad Boy Zero Turn Maverick Mower, courtesy of All Seasons Power Center. The Foundation reserves the right, at its sole discretion, to substitute a Prize of comparable value.

- The “Winner,” as hereinafter defined, assumes and must pay all taxes, fees and charges, including, but not limited to, license, title, and registration fees, local, state and federal taxes, and destination and delivery charges(per related State of Ohio laws and regulations). The Foundation assumes no responsibility for the Winner's tax and/or legal obligations, including the payment of taxes, and suggests the Winner consult his/her tax and/or legal advisor.

- The Winner must provide The Foundation with all necessary information required for tax purposes prior to delivery of the Prize. Failure to do so within ten (10) days of such request shall result in an automatic forfeiture of the Winner's Prize.
- All costs incurred subsequent to transfer, such as fuel, oil and maintenance not specifically covered under the manufacturer's warranty, are the sole responsibility of the Winner. ☞ The Prize is a new ATV awarded "AS IS" with no warranty or guarantee, either express or implied, by The Foundation.
- The Winner must claim the Prize within thirty (30) days of notification. Otherwise such Prize will be awarded in succession to first and then second alternate, as described below. In the event that a Winner does not claim the Prize or is determined to be ineligible to receive the Prize, no other Prize will be awarded or substituted. The Prize is not transferable.

**Prize Drawing:** The Prize drawing will take place on Saturday September 17<sup>th</sup> 2022, at The Foundation Annual Pig Roast and Auction. One Ticket will be selected at random for the Prize in accordance with Ohio laws by representatives of The Foundation. The first Ticket selected from among all entries that meet the requirements as set forth in these Official Rules will win the Prize. Two (2) successive alternates (first and second alternate) will be drawn at the same time. In case the Winner does not claim the Prize or is deemed otherwise ineligible, the Prize will be awarded to the alternates in succession. Alternate names will not be disclosed or announced unless the original Winner is disqualified. The Prize will be awarded to the individual whose name appears on the Ticket (the "Winner") as submitted for the contest. Purchasers of the Ticket will not be deemed to be the Winner unless his/her name appears on the Ticket. The Winner's name will be announced on The Foundation's website on Monday, September 19, 2022. The Winner will be notified by the telephone and/or email addresses listed on the Winner's Ticket form and need not be present to win. Only one eligible person may be entered in the Raffle per Ticket sold. If the name of more than one person is submitted with a Ticket purchase, the first name on the Ticket form will be declared as the Winner. If the winning Ticket contains incomplete information, or the Ticket is otherwise deemed non-compliant with the Official Rules, that Ticket will be deemed to be void and the first and second alternate Winner will be notified. The Foundation reserves the right to reject any Ticket purchase submitted with payment that does not constitute "good funds" or that is otherwise non-compliant with the Official Rules.

**General Terms:** By entering the Raffle, the Winner agrees that his/her name and/or likeness may be disclosed to and used by the news media, All Seasons Power Center and/or the Foundation for promotional purposes without additional compensation. In addition, each participant releases the corporate entities of The Foundation, All Seasons Power Center and their respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all liability for injuries, losses or damages of any kind caused by participating in the Raffle or winning the Prize, or resulting from acceptance, possession, use or misuse of the Prize. The Winner of the Prize and/or their family, heirs, associates or other interested parties agree to indemnify and hold harmless the corporate entities of the Foundation, All Seasons Power Center and their respective parent or affiliated companies, directors, officers, employees, volunteers and agents from any and all losses, damages, rights, claims and actions of any kind arising in connection with or as a result of the Winner's acceptance or use of the Prize. All Ticket sales are final. A Raffle participant's sole and exclusive remedy for the Foundation's breach shall be limited to the return of the purchase price

paid for his/ her Ticket(s). In no event shall the corporate entities of the Foundation, All Seasons Power Center and their respective directors, officers, employees, and volunteers be liable to any party for any loss or injuries to earnings, profits or goodwill, for any incidental, special, punitive or consequential damages of any person or entity whether arising in contract, tort or otherwise, even if advised of the possibility of such damages by counsel. By purchasing a Ticket and choosing to participate in the Raffle, each Raffle participant acknowledges and agrees that the Foundation has the right, in its sole discretion, to elect not to proceed with the Raffle for any reason whatsoever or for no reason, and in such event, a participant's sole and exclusive remedy shall be to receive a refund of the full price paid by such participant for each Raffle ticket purchased, without interest.
